A volatility reducing agent for use with XtendiMax 2 Herbicide with VapourGrip Technology, Roundup Xtend 2 Herbicide with VapourGrip Technology and Roundup Ready® PL Herbicide with Plantshield® Technology + XtendiMax 2 Herbicide with VapourGrip Technology.

RESTRAINT: DO NOT mix with any other herbicides, including any other dicamba formulations.

For addition to the following herbicides and tank mixtures containing dicamba to reduce volatility when applied to cotton crops containing XtendFlex® herbicide tolerance technology: XtendiMax 2 Herbicide with VapourGrip Technology, Roundup Xtend 2 Herbicide with VapourGrip Technology and Roundup Ready PL Herbicide with Plantshield Technology + XtendiMax 2 Herbicide with VapourGrip Technology	1.0% v/v	To be included in all applications of XtendiMax 2 herbicide, Roundup Xtend 2 herbicide or XtendiMax 2 herbicide + Roundup Ready PL herbicide mixtures when applied to XtendFlex cotton, as per the labels of XtendiMax 2 and Roundup Xtend 2. Fill the spray tank with three quarters of the required volume of clean water and start agitation. Add the required amount of VapourGrip Xtra Agent and agitate for 10 minutes before adding the required amount of XtendiMax 2 or Roundup Xtend 2, as per their respective labels. Top up to 100% of the required volume with clean water. Agitate for a further 10 minutes before commencing spraying. Continue agitation until spraying has been completed. Always follow the instructions on the respective herbicide product labels.

Product information

VapourGrip Xtra Agent is a tank mix adjuvant that delivers additional VapourGrip Technology to build further protection against spray mixture and spray surface conditions that may enhance dicamba volatility. XtendiMax 2 Herbicide with VapourGrip Technology and Roundup Xtend 2 Herbicide with VapourGrip Technology already contain VapourGrip Technology, however VapourGrip Xtra Agent will reduce the volatility potential even further.

PROTECTION OF WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate wetlands or watercourses with this product or used containers.

STORAGE AND DISPOSAL

Store in the closed, original container in a cool, well-ventilated area. Do not store for prolonged periods in direct sunlight.

Triple rinse container before disposal. Add rinsings to spray tank. Do not dispose of undiluted chemicals on site. If recycling, replace cap and return clean containers to recycler or designated collection point. If not recycling, break, crush, or puncture and deliver empty packaging to an approved waste management facility. If an approved waste management facility is not available, bury the empty packaging 500 mm below the surface in a disposal pit specifically marked and set up for this purpose, clear of waterways, desirable vegetation and tree roots, in compliance with relevant Local, State or Territory government regulations. Do not burn empty containers or product. Do not re-use empty container for any other purpose.
