

Bollgard 3 stacked with Roundup Ready Flex provides cotton growers with insect control and weed control options to enable superior yields, through the use of biotechnology.

Bollgard 3 cotton

Bollgard 3 is a biotechnology trait that reduces the need to spray for *Helicoverpa* spp., the main cotton pest for Australian growers

Bollgard 3 contains three proteins, Cry1Ac, Cry2Ab and Vip3A, each 'killing' larvae in a different way.

Having three different active proteins increases the sustainability of the technology as it is difficult for helicoverpa to develop resistance to more than one of the Bt proteins.

Bollgard 3 plays a critical role in protecting the technology, ensuring that it will continue to perform the way that growers need and expect for many years to come.



LEADING INSECT-CONTROL TECHNOLOGY

THREE ACTIVE PROTEINS

Each of the three proteins in Bollgard 3 – Cry1Ac, Cry2Ab and Vip3A – kills the larvae in a different way. This allows growers to effectively control *H. armigera* and *H. puntigera* for most of the cotton season.

REDUCED NEED FOR BROAD-SPECTRUM PESTICIDE SPRAYS

Bollgard 3 significantly reduces the need for application of broad-spectrum pesticides, giving other insects, including beneficial species, the chance to develop.

GREATER FIRST POSITION FRUIT RETENTION

In comparison with conventional cotton plants, Bollgard 3 plants have significantly higher first-position retention on the bottom five fruiting branches. Loss of first-position fruit can result in a significant yield penalty.






Movento is a powerful, innovative insecticide for the control of sucking pests – including **silverleaf whitefly, cotton aphid and cotton mealybug.**

Movento is better able to control sucking pests 'hiding' on the covered inner leaves that other insecticides can't reach. Movento is highly compatible with IPM production systems, being 'soft' on most beneficial species when used as directed and highly effective on pest populations that may have developed resistance to existing registered products.

Movento can be applied early in the season while beneficial insect numbers are building and it also can be applied later in the season to protect lint yield and quality.

Movento works by interfering with fat reserves which are required for insects to grow. Therefore, Movento should be targeted primarily at juveniles i.e. when pest numbers are building and the majority of the population is made up of juveniles rather than significant populations of adults.
